2. City of Pittsburg Zoning Code Update

The City of Pittsburg is undertaking a comprehensive update to its Zoning Code and Zoning Map to be consistent with the 2040 General Plan, adopted in 2024. The City Zoning Code specifies how each property in the city can be used to achieve the wide ranging and long-term vision set forth by the General Plan.

3. Pittsburg Promise Community Scholarship
